The Board of Director's meeting was called to order at 7:00 p.m. by Vice President Ms. Janice Hoberg. Roll call showed the following officers, board directors, and management personnel present:

It was moved by Treasurer Mrs. Donna Ripley Schmelz, second Director Mr. Frank Lenhart, and carried 5-0 to accept the regular meeting of the board of directors June 25, 2008 Minutes, special meetings of the board of directors June 30, 2008 Minutes, July 2, 2008, July 9, 2008 and July 16 2008 Minutes.

REPORT OF OFFICERS

- 1) Treasurer Copies of the financials are made available to members at their request and can be obtained at the business office.
- 2) Secretary i) Reported his findings on SUREWEST, i.e., SUREWEST will not make available their services based on cost and expense to them. EG does not have the correct or required cabling, (i.e., CAT 5&7) to accommodate their services. Installation of all new cable would be required and is not cost effective for SUREWEST; ii) Secretary was asked to look into AT&T and their services, however Community Director Ms Theresa Williams had already discussed this issue with the AT&T representative who stated they do not have the capabilities to accommodate TV services at this time only telephone and internet. We can expect sometime within the next couple of years before they can offer any TV packages.
- 3) Vice President Not present. No report.
- 4) President Mrs. Linda Patrick reported the following: i) announced the heroic efforts of Mr. Frank Lenhart and Mr. John Stofanick who risked their own lives to stop a runaway vehicle in which a member suffered a heart attack and lost control of their vehicle crashing through the front gate. Mr. Lenhart and Mr. Stofanick were able to bring the vehicle to a complete stop just short of hitting the clubhouse and other vehicles parked in the parking lot. The member who suffered the heart attack is recovering very well and is expected back soon; ii) reported the completion of the old business items and will soon be ready for dissemination to the general membership; iii) survey forms for smoking were completed and based on the consensus of the survey the smoking policy will stand as is with no changes; iv) called for a motion to ratify the current smoking policy. Board Action: Motion by Secretary Mr. Ed Healy, second by Mr. Frank Lenhart and carried 5-0 to accept the Smoking Policy as written in the Members Handbook with no changes; v) survey forms for the antenna will be disseminated to the general membership and will be due back NLT August 15, 2008.

- 6) Portfolio Manager i) Mr. Gary Haugstad reported they were in receipt of a letter from the California Affordable Housing Initiatives, Inc. (CAHI) reminding Eastern Garden's contract for "Section 8 Program" will expire on 12/31/2008 and if we are going to renew we must start the process now in order to avoid any losses in subsidy payments for those on the program. **Board Action:** Motion by Secretary Mr. Ed Healy, second by Treasurer Mrs. Donna Ripley-Schmelz and carried 5-0 to have management draft the renewal contract for submittal to CAHI; ii) Mr. Haugstad reported that in conjunction with the Section 8 contract renewal it will also be necessary to have an economic study done, (i.e. other apartments) within the surrounding area which will accompany the renewal contract. Estimated cost for the study is \$2,000-3,000 and is good for 5 years. **Board Action:** Motion by Secretary Mr. Ed Healy, second by Treasurer Mrs. Donna Ripley-Schmelz and carried 5-0 to have management contact an independent company that will conduct the study; iii) Mr. Haugstad also advised the board that CAHI has a changed their policy which requires Eastern Gardens to submit their 2009 budget from 90 days to 120 days prior to the end of the calendar year. **Board Action:** By consensus of the board the budget meeting usually set in October will now meet August 19, 2008, to accommodate CAHI's new policy change.
