PROJECT UPDATES

ANNUAL INSPECTIONS



Recently Eastern Gardens was inspected by its property insurance carrier and the local fire department; both inspections passed. Other upcoming inspections:

- **REAC** Real Estate Assessment Center. Who are they? REAC is another contracted division within HUD that handles on-site physical inspections for all HUD-affiliated properties, which includes Eastern Gardens because HUD co-signed for our loan making us a HUD insured property and in addition, we also participate in the Section 8 program, (i.e. Housing Assistance Program (HAP). We are not HUD owned or operated but rather insured. Because we are HUD insured we are bound by HUD's Regulatory Agreement and failure to comply with this agreement would have serious financial repercussions for us all. HUD is continuing to place stricter rules and compliance issues on properties that participate in their programs or those that are insured by them. New items that the inspectors will be looking at within the apartment units to see if they are working properly, will be, windows, doors, exhaust fans, to name a few.
- Annual In-House Inspection Prior to the REAC inspection, management will be conducting our annual in-house inspection. Please Note: Because of the additional requirements placed on us by REAC and to ensure that EG receives a passing grade with no discrepancies, management will extend its inspection to include the same items that REAC will be inspecting, for example, each room will be inspected to see if windows open and close properly, entry and closet doors swing and latch properly, bathroom and kitchen exhaust fans are working properly...etc.). Should we fail the REAC inspection, EG will then be inspected every year by REAC instead of every three years, not to mention fines and penalties levied against us. As members of the cooperative corporation and per the terms of the Occupancy Agreement everyone is expected to comply.
- **County Inspections** Every year, usually in the summer, Sacramento County inspects our Pool for compliance, we can expect the same this year.

UNAUTHORIZED VEHILCES

<u>Vehicle Registration</u>: All vehicles on the premises must be currently registered and properly insured



according to state law. Any vehicles on the premises without a current license tag (sticker) will be ticketed with a <u>96 hour</u> <u>warning notice</u>. If not addressed with Management and duly resolved, the

vehicle will be towed away at the owner's expense. (See Members/Shareholders Handbook, pg. 67)
