INCORPORATION Vs UNINCORPORATION

Eastern Gardens (EG) Statement of Information (SOI) which is filed on or before November every odd number of year with the California Secretary of State's office, (e.g. 2013, 2015...etc.). We can also file every year to show the changing of the officers at a cost of \$1.00 but it's a must to ensure that we file on the odd years. Approximate cost is \$20.00. So what's the purpose or advantages of filing?

I. ADVANTAGES TO INCORPORATING A. Limited Liability

The main advantage to incorporating is the limited liability of the incorporated company. Unlike the sole proprietorship, where the business owner assumes all the liability of the company, when a business becomes incorporated, an individual shareholder's liability is limited to the amount he or she has invested in the company.

If you're a sole proprietor, your personal assets, such as your car can be seized to pay the debts of your business; as a shareholder in a corporation, you can't be held responsible for the debts of the corporation unless you've given a personal guarantee.

On the other hand, a corporation has the same rights as an individual; a corporation can own property, carry on business, incur liabilities and sue or be sued.

B. Corporations Carry On

Another advantage of incorporating is continuance. Unlike a sole proprietorship, a corporation has an unlimited life span; the corporation will continue to exist even if the shareholders die or leave the business, or if the ownership of the business changes, this is referred to as perpetual existence. Perpetual existence is an advantageous aspect of an incorporated busi-

ness. Perpetual existence means that the life and continuation of the business will not be affected by the withdrawal or death of one of the owners. An unincorporated business's existence, as well as its operation, is generally disrupted by the withdrawal or death of one of the owners. By incorporating this risk is eliminated.

D. Income Control

If you incorporate your small business, you can determine when you personally receive income, a real tax advantage. Instead of getting your income when it's received, being incorporated allows you to take your income at a time when you'll pay less in tax.

E. Potential Tax Deferral

Becoming incorporated gives us tax deferral potential. Because we can defer paying some tax until a later time, you may be able to realize tax savings if you are then in a lower tax bracket, or if the tax rates have fallen.

F The Small Business Tax Deduction

If you incorporate your small business, your corporation may qualify for the small business deduction. This annual tax credit is calculated at the rate of 16% on the first \$200,000 of taxable income, which may be a much lower tax rate than that applied to your personal income. Also, you can deduct mortgage interest and property taxes.

H. Increased Business?

Having Ltd., Inc., Ltee., or Corp. as part of your company's name may increase your business, as people perceive corporations as being more stable than unincorporated businesses. If you're a contractor, you may also find that some companies will only do business with incorporated companies, because of liability issues. (Continued on page 2, top left column)

II. DISADVANTAGES NOT TO IN-CORPORATE

While there are several advantages to incorporating, there are also disadvantages that need to be considered. The main disadvantages of incorporating, I think, are the increases in paperwork and cost, which can be substantial compared to a sole proprietorship or partner-

A. Another Tax Return

When you incorporate your small business, you'll have to file two tax returns each year, one for your personal income, that is, shareholders, and one for the corporation. This, of course, will mean increased accounting fees. Unlike a sole proprietorship or partnership, corporate losses can't be deducted from the personal income of the owner.

B. Increased Paperwork

There is a lot more paperwork involved in maintaining a corporation than a sole proprietorship or partnership. Corporations, for example,

C. No Personal Tax Credits

Another disadvantage of incorporating is that being incorporated may actually be a tax disadvantage for your business. Corporations are not eligible for personal tax credits. Every dollar a corporation earned is taxed. As a sole proprietor, you may be able to claim tax credits a corporation could not.

D. Less Tax Flexibility

A corporation doesn't have the same flexibility in handling business losses as a sole proprietorship or a partnership. As a sole proprietor, if your business experiences operating losses, you could use these to reduce other types of personal income in the year the losses occur. In a corporation, however, these losses can only be carried forward or back to reduce the corporation's income from other years.

E. Liability May Not Be As Limited As You Think

The prime advantage of incorporating, limited liability, may be undercut by personal guarantees and/or credit agreements. The corporation's much vaunted limited liability is irrelevant if no one will give the corporation credit. When a corporation has what lending institutions consider to be insufficient assets to secure a loan, they often insist on personal guarantees from the business owner's. So although technically the corporation has limited liability, the owner still ends up being personally liable if the corporation can't meet its repayment obligations.

F. Registering A Corporation is Expen-

A further disadvantage of incorporating is that corporations are more expensive to set up. A corporation is a more complex legal structure than a sole proprietorship or partnership, so it's logical that creating one would be more complicated and costly.
