Dear Eastern Gardens Membership:

**Background**: Recall petitions containing at least 10% of the members' signatures were received on May 18, 2015 for the recall of Board members Jeff Lema and Shirley Brown. The Board is required by law to schedule a special meeting upon receipt of a petition signed by 10% or more of the membership.

**Purpose**: Notice is hereby given that a special meeting will be held pursuant to Corporation Codes §§7222(a), 7511 and 601(c) on July 16, 2015, at 6:30 PM at the Eastern Gardens Clubhouse located at 3045 Eastern Avenue, Sacramento, CA 95821, in order to: (1) conduct an election for the recall of Directors Lema and Brown, and (2) if the recall vote is successful, then elect 2 new directors.

If the recall is successful, the two candidates receiving the highest number of ballots shall be elected to the Board to fill the remaining terms for Directors Lema and Brown. If the recall is unsuccessful, Directors Lema and Brown will continue through the rest of their current terms.

**Enclosure**: Enclosed please find a candidate nomination form. Interested and qualified members are encouraged to submit their nominations pursuant to the instructions on the enclosed form. All forms must be received by the cooperative office no later than 3:00 p.m. on June 13, 2015 in order to be included on the ballots. The Association will mail the members their recall voting packages and ballots on or by June 16th, which is 30 days before the scheduled vote.
